

## 欧盟化学品注册、评估、授权和限制(REACH)法规声明 EU REACH DECLARATION LETTER

致: 圣邦徽电子(北京)股份有限公司的客户

To: CUSTOMERS OF SG MICRO CORP (SGMICRO)

欧盟新化学品注册、评估、授权和限制法规,简称REACH (Registration, Evaluation, Authorization and Restriction of Chemicals),已于2007年6月1日正式生效,指令要求凡进口和在欧洲境内生产的化学品必须通过注册、评估、授权和限制等一组综合程序,以更好、更简单地识别化学品的成分来达到确保环境和人体安全的目的。法规于2008年6月1日开始对大于等于(≧)1t/年的物质实施分阶段物质注册,该分阶段物质注册最晚截止日为2018年6月1日。

REACH (Registration, Evaluation, Authorization and Restriction of Chemicals, EC 1907/2006) is the new European.

Union (EU) chemical substances regulatory framework. Its aim is to ensure a high level of protection of human health and the environment. REACH has entered into force since June 1, 2007 and will be phased in over an 11 year period (until 2018).

## 为此, 圣邦徽电子(北京)股份有限公司 (以下简称本公司) 声明并保证:

1. 本公司及上游供应商已经完成对所有产品所含物质的信息收集并制定了相应的解决方案和计划,以确保在REACH法规规定的期限内,于必要时,对所有的产品中所含物质皆在REACH法规管制下完成预注册、注册、通报、申请授权或限制;

According to REACH requirements, SGMICRO, together with our upstream suppliers have completed the data collecting about substances of all products and relative action plans towards REACH to ensure that all substances regulated under REACH are pre-registered, registered, notified, applied for authorization and restriction within the regulated period of time if necessary.

All products and other materials provided by SGMICRO and our upstream suppliers are in fully compliance with EU SVHC and Annex XVII, all SVHC substances are less than 1000ppm;

3. 若随欧盟SVHC清单更新,当产品内所含高关注物质(SVHC)包含以下情况时,本公司会根据REACH法案的要求及时披露必要信息:

SGMICRO is committed to disclose information to its customers based on the then EU SVHC list as updated from time to time and confirm that its products contain substances in the SVHC candidate list per the below conditions:

存在产品内的此物质之总量超过1吨/年/每制造商或进口商;

The substance is present in those products in quantities totally over 1 tonne per producer or importer per year;

该物质存在产品中的浓度超过0.1wt%;

The substance is present in those products above a concentration of 0.1% weight by weight (w/w).
